**GENERAL:** Although shown in our itinerary as a single unit of sale, the package rate is a result of combining different components for your convenience. Where applicable, a professional tour director will accompany tours while traveling by motor coach. In the event that a group numbers less than 30 persons, we reserve the right to operate the tour in minibus or private car with a bilingual driver/guide. Local visits to some venues/site are given by an official local guide. The company reserves the right to cancel the service if the minimum number of people required to operate is not reached at any time. The company will provide a full refund for the tour/cruise only. **Limited availability of staterooms; only 30 staterooms have been assigned to the group (8-Inside Cat IB, 8-Outside Cat OB, 8-Outside Cat OA, 6-Balcony Cat BA). Additional staterooms or staterooms of other category available at market rates on the day of booking.** Voyages Terra Natura is not responsible for typographical errors or omissions.

**INCLUDED IN PRICE:** 3-nights' accommodation at Wellington Hotel 3\* (or similar) in NYC with breakfast, transfer from hotel to NYC Cruise Terminal, and NCL cruise in chosen stateroom. The prices advertised in this brochure include all Canadian taxes and service charges and GST and/or HST. The rates DOES NOT include the contribution to FICAV of \$1.00 per \$1,000 of tourist products or services purchased. Cruise payment subject to Terms and Conditions set out by Cruise Company. Full payment is due June 15, 2019 with outstanding balance paid using credit card or cheque. Insurance premiums can be paid by credit card via our on-line portal. For best benefits, insurance should be purchased with deposit. Airfare must be purchased with a credit card Voyages Terra Natura reserves the right add a surcharge if the dollar declines by more than 5% against the USD based on foreign exchange rates in effect on July 1, 2018.

**PASSPORT AND VISA:** A photocopy of your passport must be received with your registration. Passport must be valid through **February 28, 2020**. For any name changes or corrections a \$200 CAD administration fee will be charged plus any fees charged by airline and/or cruise company. It is the passenger's responsibility to have in order and to carry all personal and family documentation as is required according to the laws of the country or countries to be visited. Before departing on the trip, you must make sure you are in compliance with all the applicable rules and requirements relative to visas in order to enter the countries you will be visiting without incident. You will be responsible for obtaining your own visas, passports, vaccination certificates, etc. If an Authority refuses entry to a country on individual grounds, the consumer will be responsible for any resulting costs and the conditions and rules established for the case of voluntary cancellation of services will apply.
